Special Use Permit

Mrs. Schmidt stated they are not asking for rezoning, they are not hurting anyone, they will make improvements to the property, and they questioned the legality of resolution 23-02.

David Finnigan stated he is in favor of approving the special use permit. He does not want a bar there.

Lance Molina- from Gretna, Nebraska discussed the Schmidt's character and the constitution. He asked if 23-02 was still on the table. He showed a picture from his daughter. He stated his concerns/accusations with board members conduct.

Chairman Swenson reminded the audience that she has never sway anyone to vote one way or another. She called a special meeting to any questions and give the board members more information so that they would be able to make an informed decision. She also stated other municipalities don't allow reapplying. She discussed issues with Mrs. Schmidt regarding the property and property pins.

Doug Schmidt- asked the board to consider approving their permit.

Board member Tim Glas rebutted the Schmidts claims saying people want to know why the village is still allowing this to continue, they have spent a lot of money, and furthermore the claims against the Chairmen are completed unfounded. The meeting was posted in the 3 legal places required. He also stated

that people aren't happy with the Schmidts as they are not willing to help with village events, why they won't fix their fence, and asked if they will be good neighbors.

Board member Madison Garey asked if the Schmidts would allow building inspections. Mrs. Schmit said they would.

Board member Joe Shera stated he came to the special meeting to gather information only. He is not influenced by others; he will vote on what is best for the village. And he wishes he had more time to further understand this application before voting.

Board member Tim Glas discussed going into executive session.
